Notice for online counseling for Post Graduate Homeopathy seats in West Bengal 2015

The online counseling for post graduate Homeopathy seats in West Bengal for 2015 will commence from **11th November 2015**. The eligible candidates out of WBP GHAT 2015 are allowed to take part in this counseling provided they pay the counseling fees either through offline or online method.

In **offline payment method**, the eligible candidate can log in to the website of WBUHS and click on the link for online counseling and can generate e-challan. The e-challan contains bank copy, candidate copy and WBUHS copy in it. After taking print out of the computer generated e-challan, they are required to pay the counseling fees at any branch of United Bank of India along with the e-challan copy during the stipulated banking hours. The bank authority will provide them unique Transaction ID and communicate the same to the counseling committee of WBUHS at the end of the banking hour. The bank copy part of the e-challan will be retained by UBI authorities. The WBUHS copy has to be submitted at the respective colleges by the candidates who are allotted a seat out of online counseling. The transaction ID received through e-challan method will be uploaded in the counseling website on the same day by 10 pm after which the eligible candidate can register online using the transaction ID. In case of any discrepancy the transaction ID uploaded in the counseling website and available for consultation under “view transaction” will be final.

The amount of counseling fees is Rs 3000/- (three thousand only) with the bank charges as applicable.

In **online payment method**, the eligible candidate can log in to the website of WBUHS and click on the link for online counseling and can log in to the link for online payment through Bill desk interphase where candidate can pay the online counseling fees by credit/debit card or net banking method. After successful payment candidate will be returned to the counseling page where the transaction id will be uploaded immediately and by using the transaction ID the eligible candidate can register online at once. The statement of online payment will be available to take print out for future correspondence. If the payment is unsuccessful, then the money deducted from the candidate's bank account is reverted back in few days as per standard online payment procedure. If the payment is successful by candidate cannot return to the counseling website due to link failure then candidate must not panic or pay twice. He/she must wait till 8 pm of that day as such successful payment data will be shared by Bill desk to counseling committee and the IDs will be uploaded in the website. Once the candidate can view his/her transaction ID then he/she can register online with the help of the same.

The amount of counseling fees is Rs 3000/- (three thousand only) with the online banking gateway charges as applicable.

After the seat allotment process is over the result will be declared and eligible and allotted candidates have to report to the respective institutes within stipulated time frame for admission with the required original and attested photocopies as mentioned in the bulletin for WBP GHAT 2015 vide memo no COE/UHS/1213/2015 dated 29.08.2015.

If any malpractice is noticed at any point the candidature of the concerned will be rejected at once. No claim of counseling or admission will be entertained after the stipulated dates of counseling and admission as will be mentioned in the counseling schedule.

All the matters of dispute will be under the jurisdiction of the Hon'ble High Court of Calcutta. This notice is issued in the interest of the public and all concerned are informed accordingly.
